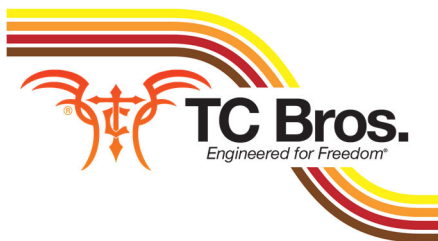

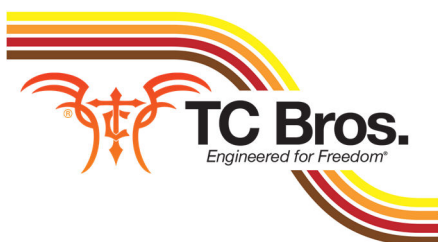

WHOLESALE DEALER ACCOUNT TERMS AND CONDITIONS

PURCHASING:

All TC Bros Choppers LLC Authorized Wholesale Dealers must place their orders via our website www.tcbroschoppers.com. Upon approval of your submitted dealer application, you will be assigned a dealer login and password to access our website and view dealer pricing. There is no minimum order size or "buy in" to establish a dealer account, however, all TC Bros Choppers LLC dealers are required to purchase a minimum of \$200 annually to maintain dealer status. If an account falls below the \$200 annual purchase minimum, the dealer account status will be revoked and retail pricing will be applied to the account for any future purchases made. Payment methods currently accepted are: Visa, Mastercard, American Express, Discover, and Paypal. TC Bros Choppers LLC does not extend credit terms to dealers, thus all orders must be paid in full upon checkout before the order will ship. All dealer orders over \$500 receive free shipping in the Continental USA only (Hawaii, Alaska, & International addresses excluded). Most orders placed before 1:00pm EST typically ship out the same day. TC Bros Choppers LLC does not backorder items. If you see an item that is not in stock on the website, and you would like to be notified when it returns to stock, please use the out of stock email notification feature on the product's webpage. All dealer orders are shipped from our Wauseon, OH warehouse. We maintain an active inventory of all of our products and do not drop ship items to dealers. (For drop shipping items to your customers, please refer to our "Drop Shipping" section below)

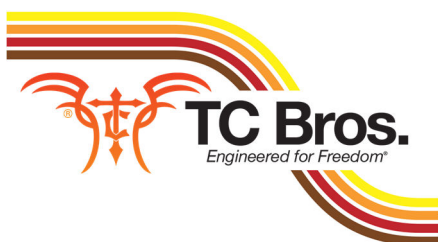

DROP SHIPPING:

TC Bros Choppers LLC encourages its dealers to maintain an active inventory of products in order to offer the fastest and best possible service to retail customers. However, we do honor and process drop ship orders with no additional fee currently. The proper way to place a drop ship order is through our website www.tcbroschoppers.com. During the checkout process you will need to change the "SHIP TO" address of the order to that of the customer that you would like the order drop shipped to. Please leave the "BILL TO" address as is required by the payment method you are using or your payment may not process properly (especially true for credit/debit card orders). TC Bros. Choppers, LLC reserves the right to amend drop shipping policy at any time.

WARRANTY/RETURNS:

All returns are subject to a 15% restocking fee unless the return is a result of our error (you received an incorrect or defective item, etc). Items must be returned in new, unused, unopened condition within 30 days of original purchase date or additional fees may apply. TC Bros. Choppers, LLC must be contacted before returning any item to receive a returned merchandise authorization (RMA) number. RMA number must be clearly marked on the outside of the package or the package will be refused and returned to sender. Original shipping is non-refundable and return shipping is at buyer's expense unless the return is a result of our error (you received an incorrect or defective item, etc). If item is determined to be fit to return after examination by TC Bros Choppers LLC, credit will be issued using the same payment method as the original purchase within 30 days of receiving returned item. TC Bros. Choppers, LLC reserves the right to amend this return policy at any time.
